



Public Community Meeting Minutes – Under Sun Acres Green Energy Inc.

Date: December 1st, 2023

Time: 5:30 PM – 6:30 PM

Overview:

The Qualified Applicant and Proponent Sun Acres Green Energy Inc., conducted a virtual public community meeting to share the information about its proposed natural gas-fired engines cogeneration expansion of the existing cogeneration facility in Staples, at the existing greenhouse location at 620 Mersea Road 10 which will be submitted into the Independent Electricity System Operator (“IESO”) Long-Term 1 Request for Proposals (“LT1 RFP”) to support the Ontario electricity system increasing needs for capacity and reliability. The project slides were presented, and formal group questions and answers period was opened to the public.

The following is the summary of the Meeting Minutes. Appendix A contains the Under Sun Acres Green Energy Inc. slides presented during this virtual public meeting. Appendix B contains screenshots with time stamps of the virtual meeting taking place on Dec.1st.

Meeting Minutes:

- 5:20 PM Google Meeting room opened to the public.
- 5:30 PM Greeted attendees and provided time to allow the public to enter the session.
- 5:40–6:05 PM Presentation by Under Sun Acres Green Energy Inc. team.

Welcomed attendees and stated the purpose of the public community meeting to share the Under Sun Acres Green Energy Inc. proposed project planned for submission into the IESO LT1 procurement. Introduced the Project Name: Under Sun Acres Green Energy Inc. and the Proponent Name: Under Sun Acres Green Energy Inc. and communicated the project website: www.undersunacres.com/cogen-exp

Communicated the Need and Background to the attendees that the goal of the LT1 RFP is to fulfill the need of the province’s capacity gap, and competitively procure up to 2505MW of year-round capacity services. Related the natural gas-fired facilities’ critical role in the LT1 procurement as a diversification of resources to ensure reliability and affordability, and fulfil short-term energy needs to contribute to the province’s longer-term energy transition in the pathways to decarbonization. Communicated the LT1 RFP requirement that any proposed natural gas-fired project implements a required GHG Abatement Plan for natural gas to comply with the Clean Electricity Regulations under the Canadian Environmental Protection Act 1999.



Introduced the Proponent Under Sun Acres Green Energy Inc. as the Eligible Expansion Counterparty. The Proponent's background of operating greenhouses and natural gas-fired cogeneration delivering up to 12.93 MW electricity output to the Ontario electricity system.

Introduced the Project, Under Sun Acres Green Energy Inc. its technology using one natural gas-fired power engine of total Nameplate Capacity of 3.33MW. Communicated the location of the project site at 620 Mersea Road 10, Staples, ON, NOP 2J0. Discussed the project development status with key milestones including target environmental assessment period Q1'24-Q2'24, target construction period of Q4'24-Q1'27, target commercial operation date of May'27 and other important project milestones. Discussed the key safety aspects of the proposed project including that the project will use a proven natural gas-fired system technology, in a containerized solution fully ESA and TSSA approved and compliant with the Environmental Protection Act noise pollution control guidelines. Shared that the qualified applicant has developed standard operating procedures for operation, maintenance, emergency response and pre-incident plants which will be made available to the first responders. Also, the existing Emergency Response Plan will be adopted with input from local emergency services and the fire department. The plan will include details and procedures for safety shut down of the system if outside standard operating parameters before an incident can occur. It will also include periodic training for the staff and first responders.

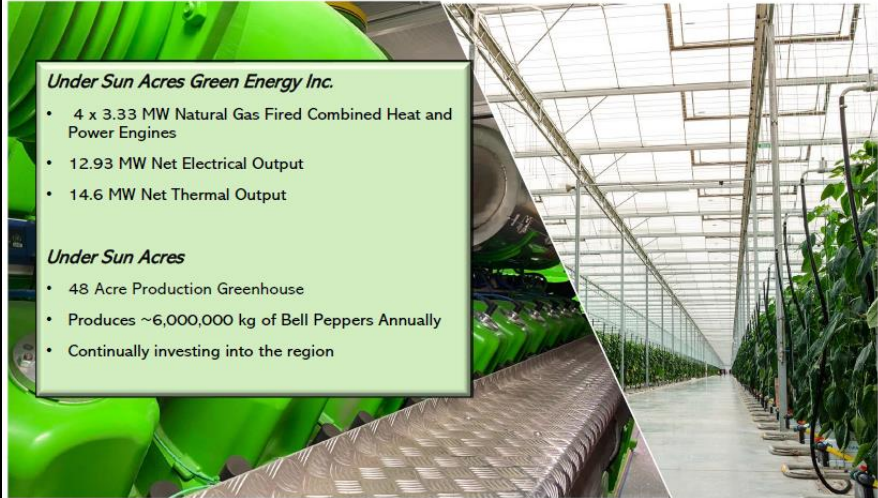

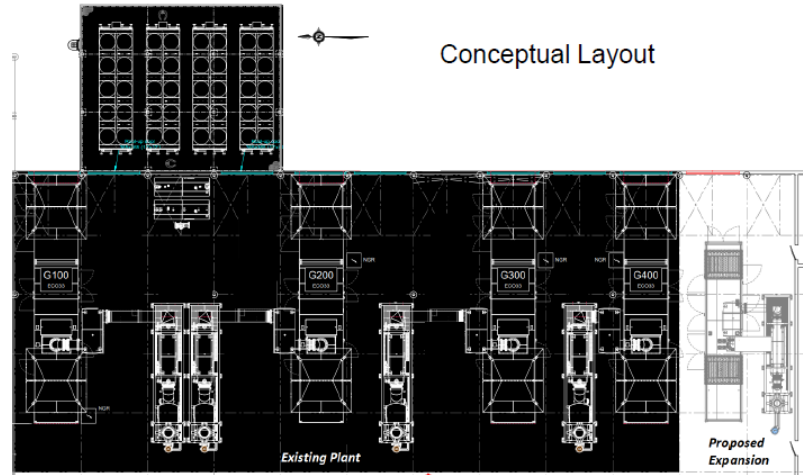
